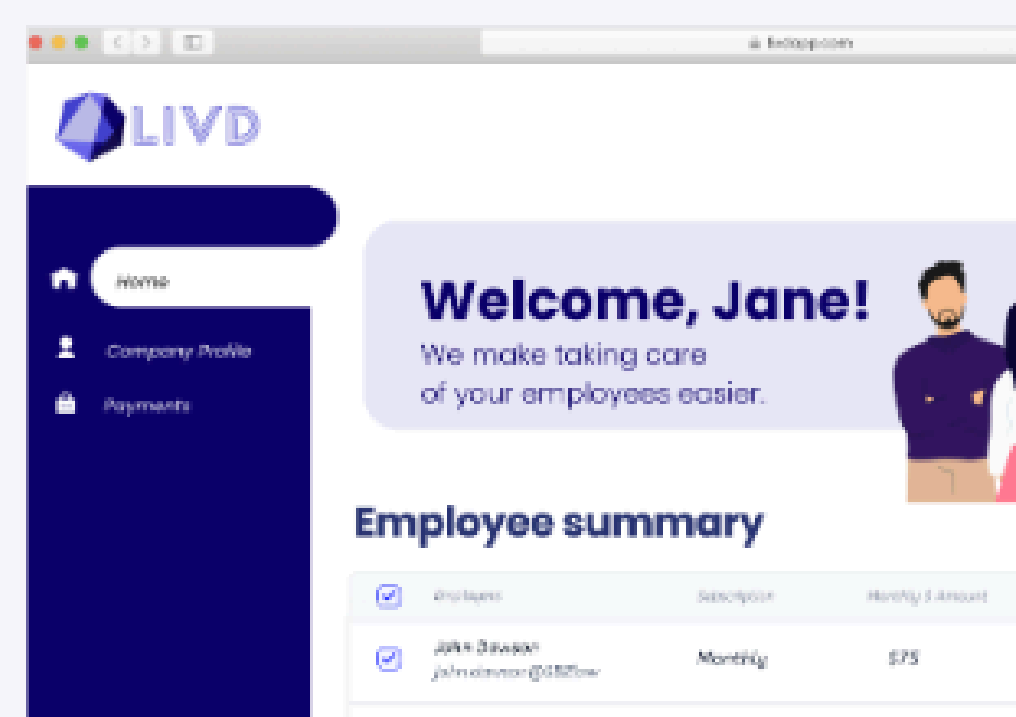

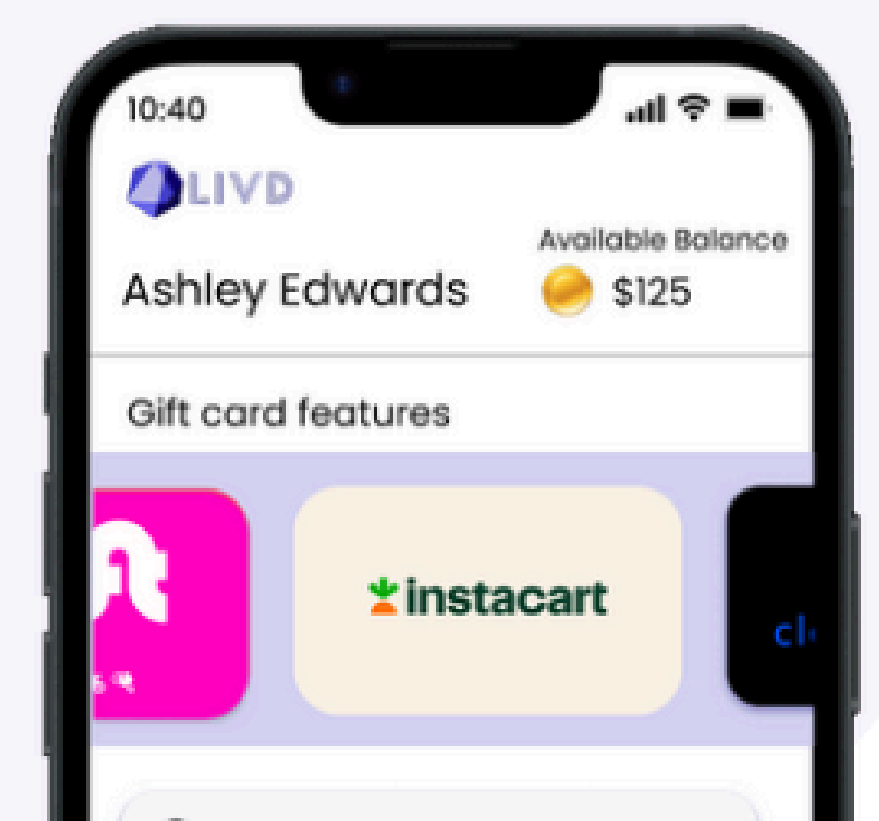

These customizable, employer-sponsored spending accounts let employees allocate funds based on their personal priorities.

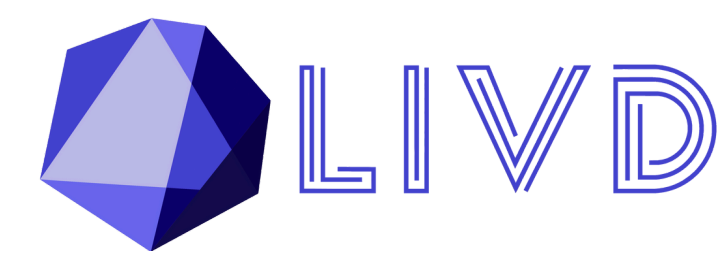
